86 MATTERS ARISING

87 JUBILEE HALL – WINDOWS AND DOORS COVERINGS

Options for window and door coverings had been discussed at previous meetings. The quotes accepted as being reasonable and the fabric of the roller blinds was chosen.

RESOLVED that Pretty Pleats should complete the work for installing the blinds to the Jubilee Hall

Barbara Bradley had incurred a fee for the quotes received by John Lewis and had asked that be reimbursed.

It was resolved that on this occasion the fee would be reimbursed but to remember in future that all costs must be passed by the Council in future. **ACTION** Clerk to write to this effect and reimburse cost

94 HKSD COUNTRY MARKETS BANNERS

A request from HKSD Country Markets to install a temporary banner outside the hall to advertise their markets a few days before each event was considered and no objections were noted.

A request from HKSD Country markets to drill 2 screw holes into the brick of the village hall for temporary banner – they will remove the screws after each event, was considered however HKSD have since opted to continue to use a more easily removed advert using the poles around the green in front of the Village Hall
