63 MINUTES OF LAST MEETING

64 MATTERS ARISING

Trees: Sarah Ward to be contacted re T1 on her land overhanging the picnic area. **SD Village green:** reminder to Solicitors that the dead tree should be removed before transfer to the Parish Council

Insurance re possible damage to surfaces in fields: The Parish Council Insurance does not cover for damage should this occur. There is cover available for cricket/bowling greens but is not suitable for our open spaces. Cllr Page asked that the Hire Conditions, explain that costs due to damage of field surfaces during events will be passed to the Hirer.

Heathside Grandstand: This is being painted again by Lions Club in time for their Fete 6th July 2013

Shrubbery Road Play area: Approx 70 mats were due to be removed from around the Goal area and taken to an auction, following previous discussions on how best to manage this area, where the mats were coming loose and becoming a trip hazard. The area is now bare ground.

66 PUBLIC CONVENIENCES

Horton Kirby Environmental Centre had found the new shorter Toilet Opening times to be sometimes inconvenient when taking groups of school children to the river for lessons. The Clerk had suggested they hold a key to the Public Toilets for out of season use when necessary.

The Committee offered a key to the Disabled Toilet on an emergency use only so that any extra need for cleaning was kept to a minimum.

67 HEATHSIDE

- The Committee considered a request from Swan Archers to become regular users
 of Heathside. There were concerns raised over public safety as this is an open
 public space and clashes with the Football schedule which is quite busy. The
 committee regretted not being able to accommodate the Club and gave suggestions
 for other sites.
- The Committee considered moving bin in far side of field next to Dog Bin to avoid dog walkers using the litter bin. As the Dog Bin was more easily moveable Mick Burroughs offered to move it to near the litter bin.

• The impact of rabbits on playing field and comment from Insurers regarding any damage they might cause was considered. The foorball club stated that they always check the pitch before play and fill any holes so players are not in danger of hurting themselves.
